Legal framework

A.M. of 22.01.2007 (MB: 05.02.2007) : Ministerial Decree setting the special criteria for approving specialist doctors, internship supervisors and intern departments for insurance medicine and medical expertise.

Presentation

This certificate aims to prepare doctors for authorisation as holder of the professional title of 'compétence' in insurance medicine and medical expertise.
