LL.M in **EU Law**

This LL.M in EU Law offers specialized training in European competition and intellectual property law. It allows students to complete the knowledge they acquired in a second university cycle.

ASSETS

- Multidisciplinary training involving international specialists

The ambition of the LL.M in EU Law at the University of Liege is to train real practitioners by offering a highly specific and technical program with a strong focus on interdisciplinarity (economics of competition law, international and commercial aspects of intellectual property, data protection and artificial intelligence).

Students receive the tools to solve legal problems that will arise in their professional life. The bilingual French-English programme offers students the opportunity to perfect their legal vocabulary knowledge of the two languages most commonly used within the European institutions.

The LL.M programme follows the teaching practice model that has made Anglo-Saxon universities so successful and offers, in addition to some ex-cathedra courses, practical case studies and discussions in seminars. Upon request or depending on sanitary circumstances, these courses can be taken online by students.

Students are also offered the opportunity to participate in a moot court or to take on the writing of an academic paper published in a scientific journal and signed in their own name.

PRACTICALITIES

DURATION

1 year (possibility of spreading over 2 years)

ORGANISATION

Courses are given throughout the academic year (from September 15 to June 30) on the Sart-Tilman campus. Active participation in the course is required.

REQUIREMENTS

The LL.M in EU Law is accessible to students who meet the conditions for access to the Master's program: either they hold a title, diploma, degree or certificate of higher education, in the French Community or outside it, or they have acquired competences valued at least 300 credits.

FINAL YEAR THESIS

The LL.M in EU Law offers students the possibility to replace the writing of a thesis either by a two-month internship in an institution, company or law firm specialized in competition or intellectual property law, or by an international moot court competition.
