Overview of the programme :

Application criteria, Fees and Scholarships !

Apply

Requirements :

- Undergraduate degree diploma (240 ECTS)
- English proficiency (B2)

All academic discipline backgrounds are welcome!

Important dates :

EMMIE starts on the **1st of September 2022 in ZSEM (Zagreb).**

Applications are open **until the 21 March 2022.**

Fees

The programme fees are 13,500€ for 18 months

This includes :

- Registration fees
- Administration fees
- Health Insurance
- Access to uni's infrastructures
- Assistance from international departments of each University

Scholarships

EMMIE is an Erasmus Mundus master program. This means the very best students can candidate to get an Erasmus Mundus Grant.

This scholarship includes two different contributions:

- Exemption of registration fee (13,500€)
- A grant of 1,400€ per month for the entire duration of the study program (18 months) as a contribution to travel, subsistence and installation costs.

Other grants:

- Candidates are strongly recommended to solicit scholarships or loan opportunities in their own country. Students who do not have a scholarship can apply for reduced participation fees. If you are applying as a self-funded student and wish to be considered for a waiver, please mention it in your application file.
